**RE: Support for LB 880 - Provide for an early childhood element in a comprehensive plan developed by a city**

Dear Chairman Wayne and Members of the Urban Affairs Committee,

When we support policies that bolster child well-being, we ensure that all children in Nebraska reach their full potential and contribute to their community. Voices for Children in Nebraska supports LB 880 because it ensures that local communities develop a long-term vision for its young children by assessing and promoting early childhood needs.

Early childhood development research is clear: interventions that start as early as birth show remarkably high returns for each dollar spent. The cognitive and character-building tools provided by early childhood education have even been shown to overcome poor outcomes that are otherwise demonstrated among children in at-risk circumstances.<sup>i</sup>

Access to affordable and quality early childhood programs is not just a sound investment in Nebraska's future—it also supports today's workforce by allowing more parents to work knowing that their young children are safe and cared for. Significant barriers remain for many Nebraska parents in finding and affording high quality early education, particularly for families in rural Nebraska. A recent poll showed that many Nebraska parents living in rural and isolated areas were very concerned about shortages in quality child care programs.<sup>ii</sup> Indeed, 11 Nebraska counties had no licensed child care facilities in 2015, while many more were operating near or over capacity.<sup>iii</sup>

LB 880 recognizes that early childhood accessibility is essential to planning for economic prosperity within a community. We thank Senator Hansen for his leadership on this issue and respectfully urge the committee to advance LB 880.
