
RESEARCH

IN 2022, we published the 2021 Kids Count in Nebraska Report – the 29th annual edition.

This publication serves as a trusted resource for Nebraska lawmakers, researchers, service providers, educators, and community leaders, and provides pertinent information on the well-being of all Nebraska children in the areas of health, child welfare, education, economic stability and juvenile justice.

Our commentary focused on raising the minimum wage:

- In 2020, 78.1% of children in Nebraska had all available parents in the workforce. Unfortunately, having high labor force participation does not always translate into family economic stability.
- The Covid-19 pandemic and resulting economic fallout caused **significant hardship for families in Nebraska.** The economic recovery was complicated by record-setting inflation and significant escalation in the cost of living. As a result, Nebraska families continue to struggle to make ends meet.
- In November, Nebraskans voted to raise the state minimum wage. This stepped increase will benefit workers in low-wage and essential jobs across the state. This is especially true for women, and particularly women of color, who are concentrated in jobs that pay at or just above the minimum wage.

POLICY VICTORIES

Economic Stability

In 2022, Voices for Children leveraged the results of our texting campaign to identify priority issues in communities of color, including supporting legislative efforts promoting equitable distribution of American Rescue Plan recovery funds. We participated in the successful Raise the Wage ballot initiative to support low wage families in meeting kids' needs.





Youth Justice

Voices for Children successfully opposed a measure that would have infringed on children's right to due process and record privacy. We also supported measures that provider rate increases for providers offering behavioral health services, a vital network for Nebraska youth and families in crisis.


Early Childhood

Voices for Children fought for expanded access to childcare assistance. Eligibility for childcare assistance in Nebraska was temporarily increased from 130% of the federal poverty level to 185%, with transitional eligibility to 200%. This change supports families in entering and remaining in the workforce and providers in keeping their doors open.


